CISC will form teams and compete in league play with other area Rec. "in-house" teams. Coaches and uniforms (soccer jerseys) will be provided by CISC at the first practice. Each session will have one practice and seven games. Session II practice times will be announced at a later date and e-mailed to you.

CISC may not do standings for the younger age divisions. Standings, schedules and pictures are going to be located on our web site at www.carroll-indoor.com

Note: The CISC Rec. program is designed for individuals and teams that are not playing in our indoor travel or select leagues. Those playing in our travel divisions may not play in our rec. divisions of grades 8th-9th or younger unless they play up a division (ex. A 10 year old in 5th grade who is playing on a U11 travel team would need to move up to the 6th-7th grade Co-ed Rec. league in order to play).

First Practice:

Session I-You will be emailed by CISC after your registration has been accepted. After you have registered you may then just show up at the practice time listed above. **You will receive jersey and schedule at the first practice.**

Session II-You will be emailed by CISC after your registration has been accepted. You will be emailed as to when the first practice will be. **You will receive jersey and schedule at the first practice.**

Grade: Your child's grade determines which age division they may play in unless "bumping" up if you play on a travel team.

Car Pooling: We can not accept car pooling situations.

Number of Participants: Registration is on a first come first serve basis. *Register early because the league fills up quickly.*

OUR FACILITY

Warm Up Areas - A turf and enclosed warm up area for teams to use beside the upper and lower fields. This area is fully turfed and padded & enclosed in netting and glass.

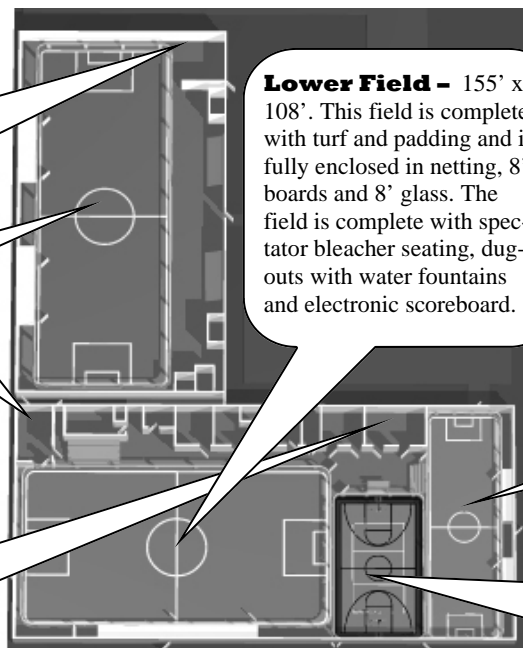
Upper Field - 170' x 90'. This field is complete with turf and padding and is fully enclosed in netting, 8' boards and 8' glass. The field is complete with spectator bleacher seating, dugouts with water fountains and electronic scoreboard.

Snack Bar - Get a quick hot dog, hamburger, grilled chicken sandwich, onion rings, popcorn chicken, pizza and much more as you watch the game.

Lower Field - 155' x 108'. This field is complete with turf and padding and is fully enclosed in netting, 8' boards and 8' glass. The field is complete with spectator bleacher seating, dugouts with water fountains and electronic scoreboard.

Intermediate Field - 135' x 62'. This field is complete with turf and padding and is fully enclosed in netting, 8' boards and 8' glass. The field is complete with spectator bleacher seating, dugouts with water fountains and electronic scoreboard.

Basketball/Volleyball Area - This area has a SportCourt® surface, adjustable basketball rims, water fountain, a NCAA approved volleyball net and standards as well as an electronic scoreboard.
