CISC will form teams and compete in league play with other area Rec. "in - house" teams. Coaches and uniforms (soccer jerseys) will be provided by CISC at the first practice. Each session will have one practice and seven games. Session II and III practice times will be announced at a later date and e-mailed to you. Standings, schedules, and weather cancellations will be posted on our web site at www.carroll-indoor.com No standings for U6 & U8.

First Practice:
