First Practice:

Note: The CISC Rec. program is designed for individuals and teams that are not playing in our indoor travel or select leagues. Those playing in our travel divisions may not play in our rec. divisions unless they play up a division (ex. A U10 travel player must play U12 co-ed rec.)

4. I further understand that CISC does not require background checks on volunteers.

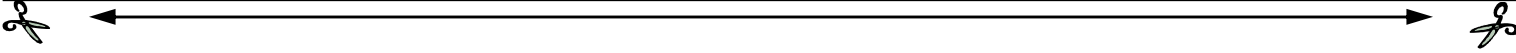
Minor Release
